A. B. I agree to abide by the findings of the Quality Review Committee and promptly respond to and rectify defects as defined by the codes and standard as stated in paragraphs A and B above.

C. I agree to use written contracts and change orders. All prices and specifications will be described in detail both honestly and accurately.

D. I agree to use only materials equal to or exceeding the quality of those specified in the contract and/or as required by code where the code shall be used as the minimum standard. Any modifications to the materials stated in the contract shall be conveyed to and accepted by the consumer in writing.

E. I agree to maintain a credit rating that is acceptable to my creditors, suppliers and subcontractors, and which conforms to the generally accepted practices within the building industry and as established by the Board of Directors of the Huntingdon County Builders Association.

F. I agree to supply the Huntingdon County Builders Association with proof of Workmen's Compensation Insurance, if I have any employees. I will also provide proof of Liability Insurance with minimum coverage of \$500,000 per occurrence. I agree to have certificates furnished to the Association as a certificate holder and they shall be named in the caveat to be notified when and/if the policy is cancelled or is no longer valid.
